Access is via the pedestrian gate only ❖ There is no access to a power source ❖ Use of the Park is offered free of charge, please be aware because it is available to the public Central Highlands Water cannot <i>guarantee</i> exclusive use ❖ A “take home rubbish” policy applies ❖ Central Highlands Water accepts no responsibility for any personal injury, property damage or consequential loss arising from you and your guests’ use of the park, park facilities and car park ❖ All rules and regulations applicable to the use of the Park by the public must be complied with at all times ❖ You must ensure that commercial providers (e.g. marquee, musicians) provide CHW with a copy of their current public and products liability insurance (Certificate of Currency), with a minimum cover of \$10 million 2 weeks prior to the event ❖ No spikes are to be used to secure items such as marquees
